

"2023 Putt for a Porsche" Sweepstakes
OFFICIAL RULES AND REGULATIONS

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT IMPROVE CHANCE OF WINNING.

ELIGIBILITY: The "2023 Putt for a Porsche" Sweepstakes (herein referred to as the "Sweepstakes") is open solely to legal United States residents that reside in the state of Georgia, and who are twenty-one (21) years of age or older as of the date of entry, and possess a valid Georgia driver's license and auto insurance card. Officers, directors, representatives and employees of Dickey Broadcasting Company, d/b/a WCNN-AM, participating sponsors PGA Tour Superstore, Hennessy Porsche, Brown & Co. Jewelers and Mizuno (WCNN-AM, PGA Tour Superstore, Hennessy Porsche, Brown & Co. Jewelers, and Mizuno collectively referred to as "Sponsor"), any of their respective parent companies, affiliated companies, subsidiaries, dealers, franchisees, licensees, distributors, suppliers, subsidiaries, participating retailers, advertising / promotion / judging agencies, persons engaged in the development, production or distribution of materials for this Sweepstakes, Compliance Sweepstakes Services (collectively, the "Released Parties") and the immediate family members (defined as spouse, parents, grandparents, children, grandchildren, siblings, - whether biological, adopted, step or in-law) of such individuals, or persons living in the same household as such individuals (whether related or not), are not eligible to participate in the Sweepstakes. This Sweepstakes is subject to all applicable federal, state, and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's and Administrator's decisions, which are final and binding in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein. Void where prohibited, taxed or restricted by law.

HOW TO ENTER: The Sweepstakes begins at 11:00 a.m. Eastern Time (ET) on Thursday February 23, 2023 and ends at 5:45 p.m. ET on Friday, March 31, 2023 (otherwise known as the "Promotional Period"). Individuals will have SIX (6) chances to qualify for the "Putt for a Porsche" competition on Friday, March 31, 2023 by registering during the "Putt for a Porsche" retail stops. Two (2) names will be drawn from the first FIVE (5) retail stops, and six (6) additional names will be drawn 30 minutes before the finale of the "Putt for a Porsche" competition as last chance qualifiers. There will be a total of sixteen (16) individuals qualified to "Putt for a Porsche." For the first six (5) retail stops, qualifiers will be selected at random after the event and notified via phone, for the finale day, and the SIX (6) last chance qualifiers will be selected randomly prior to the actual "Putt for a Porsche" competition. Last chance registration on Friday March 31, 2023 will take place from 2:00 p.m. until 5:30 p.m., and all qualifiers must be onsite by 5:30 p.m. in order to participate in the competition at 6:00 p.m. If any of the qualifiers from the first five (5) retail stops are not able to attend or do not show to the "Putt for a Porsche" competition, then we will randomly select additional last chance qualifiers from all individuals who register on Friday, March 31, 2023 until we have a total of sixteen (16) qualifiers. The retail stops will occur as follows:

- Tuesday, February 23, 2023 at the PGA Tour Superstore Kennesaw from 11a – 2p.
- Friday, March 3, 2023 at the PGA Tour Superstore Sugarloaf from 2p - 6 p.m.
- Wednesday, March 8, 2023 at PGA Tour Superstore Roswell from 11a - 2 p.
- Wednesday, March 14, 2023 at the PGA Tour Superstore Kennesaw from 2p – 6p
- Thursday, March 23, 2023 at the PGA Tour Superstore Sugarloaf from 11a – 2p.
- Finale: Friday, March 31, 2023 at the PGA Tour Superstore Roswell from 2-6 p.

To enter the Sweepstakes, participants will need to provide: full name, date of birth, home address, zip code, e-mail address and daytime phone number (with area code). Each participant that fully completes the entry form will receive one (1) Sweepstakes entry. The official clock for the Sweepstakes is the computer of the Sponsor.

Limit of one (1) entry per person, per retail stop regardless of method of entry. All required information must be completed to enter and to be eligible to win. Incomplete entries will be disqualified. Sponsor is not responsible for misdirected, late, incomplete, illegible, undelivered, or lost entries, which will be disqualified, or any unforeseen circumstances that may limit an individual's ability to participate in the Sweepstakes. Sponsor reserves the right, in its sole discretion, to void any and all entries of an entrant that submits more than the stated maximum limit of entries by using multiple/different addresses, identities, or any other methods, or who Sponsor believes has attempted to tamper with, influence or impair the administration, security, fairness, or proper play of this Sweepstakes. All entries become the property of the Sponsor and will not be acknowledged or returned.

WINNER SELECTION: The odds of being selected to participate in the “2023 Putt for a Porsche” Competition depends upon the total number of eligible entries received during each retail stop. Individuals will have five (5) chances to qualify for the “Putt for a Porsche” competition on Friday, March 31, 2023 by registering during the “Putt for a Porsche” retail stops. Two (2) names will be drawn from the first five (5) retail stops, and six (6) additional names will be drawn on the day of the “Putt for a Porsche” competition as last chance qualifiers. There will be a total of sixteen (16) individuals qualified to “Putt for a Porsche.” For the first FIVE (5) retail stops, qualifiers will be selected at random after the event and notified via phone, and the four (4) last chance qualifiers will be selected randomly prior to the actual “Putt for a Porsche” competition. If any of the qualifiers from the first five (5) retail stops are not able to attend or do not show to the “Putt for a Porsche” competition, then we will randomly select additional last chance qualifiers from all individuals who register on Friday, March 31, 2023 until we have a total of sixteen (16) qualifiers. Dates / times / locations of retail stops have been listed earlier in this document.

The Qualifiers from the first five (5) retail stops will be notified via telephone and/or email. If any of the Qualifiers cannot be reached, or do not reply, within one (1) day, an alternate Qualifier will be selected, time permitting. The Qualifiers will need to provide proof of identity before participating in the “Putt for a Porsche” Competition. Non-compliance with any requirement or obligation may result in disqualification and selection of an alternate Qualifier. Return of any prize notification as undeliverable may result in disqualification and selection of an alternate Qualifier, solely at the Sponsor's discretion. Sponsor will use reasonable efforts to select an alternate Qualifier, time permitting.

There will be a maximum of sixteen (16) total qualifiers. After registering and signing the legal waiver and the winner's affidavit/release forms we will perform a “putt off” from a length of 6 feet, 8 feet and 10 feet to determine the one (1) final contestant. The final contestant will have one (1) chance to make a putt from an undisclosed number of feet. If the finalist sinks the aforementioned putt, they will win the 2023 Porsche Macan from Hennessey Porsche North Atlanta. Any maintenance, options, upgrades and/or enhancements shall be the sole responsibility of the winner.

PRIZES: Sixteen (16) qualifiers will receive a (1) Mizuno putter valued at \$300 (Qualifier Prize). One (1) Finalist will receive a Breitling Avenger Automatic GMT 43mm Stainless Steel with White Dial watch from Brown & Co. Jewelers valued at \$4,600 (Finalist Prize) and will have the opportunity to compete in the Insured Contest for the Grand Prize 2023 Porsche Macan valued at \$70,800. Qualifiers will receive Qualifier Prize regardless of the outcome of the Insured

Contest. Finalist will receive the Finalist Prize regardless of the outcome of the Insured Contest. Value of Qualifier Prize: \$300. Value of Finalist Prize: \$4,600. Value of Grand Prize: \$70,800.

The Grand Prize Winner will be solely responsible for all expenses incurred by them while redeeming their prize, including items such as: travel and transportation, lodging, parking, gratuities, taxes, and items of personal needs (beverages, meals, snacks, souvenirs, etc.).
