

Official Contest Rules

Juntos Por Primera Vez - OFFICIAL RULES

The following represents the rules for the above named contest and by entering the contest you agree that the terms and conditions contained herein represent the agreement between you and KWHY 22 TV and its parent, subsidiary, and affiliate companies, for contests on KWHY 22 TV Los Angeles (herein as "KWHY 22 TV")

1. No purchase necessary.
2. To enter, Participants will need to visit KWHY22 TV website: www.kwhy22.com and click on "Concursos Tab" to complete registration form. Neither sponsor (if any), KWHY 22 TV, nor any of their agencies, vendors, suppliers, employees, agents or representatives are responsible for interrupted, malfunctioned, lost, late, incomplete, or misdirected calls or entry submissions. All materials submitted become the property of KWHY 22 TV and none will be returned.
