### 1. Promotion Dates

- a. Sweepstakes period is eight (12) weeks, beginning June 10, 2022 at 12:00am EDT, and ending August 28, 2022 at 11:59pm EDT.
- b. One (1) Grand Prize winners will be selected on/or about August 29, 2022.

### 2. Entry/How To Play/How to Win

- a. To enter, entrants will visit participating locations in Suffolk County, Long Island (NY), where Seagram's Escapes Cocktails are sold and look for the scan-to-win signage with QR code.
- b. Once found, entrants will scan the QR code to access the promotion landing page and entry form. Entrants will complete the entry form online and click "submit".
  - i. An "opt-in" box will ask all entrants if they want more information from the sponsors of this campaign.
  - ii. Only entrants who "opt in" to receive more information may receive emails, offers, and/or alerts from participating sponsors. No other entrant information will be shared with any participating sponsors or partners.
- c. A "Thank You" email will automatically generate confirming each entry.
  - i. Entrants can enter once per day for the duration of the contest period.
  - ii. Incomplete entries will be ineligible.
  - iii. Entries received after August 28, 2022 at 11:59pm EDT will be disqualified.
- d. On or about August 29, 2022, the Stations will randomly select one (1) winner from all entries received.
