

# FAMILY VACATION GIVEAWAY SWEEPSTAKES OFFICIAL RULES

## 1. Promotion Dates

- a. Sweepstakes period is eight (4) weeks, beginning July 8, 2022 at 12:00am EDT, and ending August 4, 2022 at 11:59pm EDT.
- b. One (1) Grand Prize winner will be selected on or about August 8, 2022.

## 2. Entry/How To Play/How to Win

- a. To enter, entrants will visit any Suffolk County, Long Island (NY) Stop & Shop location and look for the scan-to-win signage with QR code.
- b. Once found, entrants will scan the QR code to access the promotion landing page and entry form. Entrants will complete the entry form online and click "submit".
  - i. An "opt-in" box will ask all entrants if they want more information from the Sponsor, the Station, or others.
  - ii. Only entrants who "opt in" to receive more information may receive emails, offers, and/or alerts from Sponsor, the Station, or others. No other entrant information will be shared with Sponsor, the Station, or others.
- c. A "Thank You" email will automatically generate confirming each entry.
  - i. Entrants can enter once per day for the duration of the Sweepstakes period.
  - ii. Incomplete entries will be ineligible.
  - iii. Entries received after August 4, 2022 at 11:59pm EDT will be disqualified.
- d. On or about July 11, 2022, the Station will randomly select one (1) winner from all entries received.
  - i. Selection of the winner will be by random draw from all entries received.
  - ii. The decisions of the Station are final.

  - i. One entry per day per person will be eligible.
  - ii. Entries and entry requests that go undelivered will be disqualified.

- iv. Mail in entrants must reside in Suffolk County to be eligible to win.

- b. Odds of winning are based on the number of eligible entries received.

### 4. Acceptance and Delivery of Prizes

Entrants and winner and those accompanying winner agree on their own behalf, and on behalf of their heirs, successors, representatives and/or assigns, to fully and forever release and discharge CONNOISSEUR MEDIA LONG ISLAND, the Station, and each and all of their subsidiary and affiliated corporations, companies and divisions, their predecessors, successors and assigns, and their respective directors, stockholders, officers, employees and agents, of and from any and all claims, demands, agreements, contracts, covenants, actions, suits, causes of action, obligations, controversies, debts, costs, expenses, accounts, damages, judgments, losses and liabilities of whatsoever kind or nature in law, equity or otherwise, whether known or unknown, whether or not concealed or hidden, against it or any of them, that the entrants or winner or those accompanying winner have had, may have had or now have, or which they or any of their heirs, representatives and/or assigns hereafter can, shall or may have for or by reason of any matter, cause or thing whatsoever, including but not in any respect limiting the generality of the foregoing, any and all claims which or might have asserted relating to this Sweepstakes, and agree to deliver an executed release form upon request, including at the time of delivery of any prize.
