## WRRX/MAGIC 106.1's "MAGIC NIGHT ON THE TOWN"

## CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WRRX ("Station"), 6565 North W Street, Pensacola, FL, during available business hours Monday through Friday, on the Station website www.MyMagic106.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **WRRX/Magic 106.1 "Magic Night On The Town"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within twenty-four (24) hours of notification will result in disqualification.

Failure to respond to the initial verification contact within two (2) hours of notification will result in disqualification.
