

**KRBE'S "SUMMER OF 2020FREE" CONTEST  
OFFICIAL RULES**

A complete copy of these rules can be obtained by contacting radio station KRBE ("Station"), 9801 Westheimer Rd., Suite 700, Houston, TX 77042, during available business hours Monday through Friday, on the Station website [www.krbe.com](http://www.krbe.com), or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **KRBE'S "SUMMER OF 2020FREE"** contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. **NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.**

**Eligibility.** This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last 90 days or a prize valued at \$500 or more in the last 180 days or a prize valued at \$500 or more in the last or more in the last 180 days, and whose immediate family members or household members have not won a prize from the Station in the last 90 days or a prize valued at \$500 or more in the last 180 days. **Void where prohibited by law.** Employees of Station, Susquehanna Radio LLC, and each of their parent companies, affiliates, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, other radio stations serving the Station's DMA, and the immediate family members and household members of all such employees are not eligible to participate. The term "immediate family members" includes spouses, parents and step-parents, siblings and step-siblings, and children and stepchildren. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein.

2. **Contest Period.** The Contest entry period will begin at **8:00 am CT on Tuesday May 30<sup>th</sup>, 2023** and will run through **6:00 pm CT on Friday September 1, 2023** (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.

**On-Air:**

**How to Enter and Win.** Listen to the Station during the Contest Period. At or around every weekday starting on Tuesday, May 30, 2023 through Friday, September 1, 2023 at 1:20 pm CT, and 5:20 pm CT (each, a "Selection Day"), when the Station gives the cue to call, listeners must call the Station at 713-390-5723. The designated caller to the Station, as determined by the Station in its sole discretion, will be the winner for that Selection Day after providing the Station the winning listener's name and phone number, subject to verification and compliance with these Contest Rules. All entries may be played on the air. **Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:** Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished. Station's decisions as to the administration and operation of the Contest and the selection of the potential winners are final and binding in all matters related to the Contest. Failure to verify winner's eligibility may result in disqualification and forfeiture of the prize. Unclaimed prizes may not be awarded. **There will be two hundred and seven (207) cues-to-call during the Contest Period. LIMIT ONE PRIZE PER PERSON.**

**Text:** Listen to the Station during the Contest Period. At or around every weekday starting on Tuesday, May 30, 2023 through Friday, September 1, 2023 at 8:20 am CT (each, a “Selection Day”), when the Station gives the daily keyword listeners must send a text message with the keyword to 37530 during the Contest Period. All entries must be received on the weekday the keyword was given to be eligible for a chance to win a prize. **Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider.**

### **Winner Selection.**

There will be two hundred and seven (207) participants of this Contest. The designated entrants (as described above) and as determined by the Station in its sole discretion, may be awarded the qualifying prize and will participate in the grand prize drawing (subject to verification of eligibility and compliance with the terms of these rules). From 6:00 pm CT through 8:00 pm CT on Friday, September 1, 2023 the Station will call one (1) entry selected from the two hundred and seven (207) participants in a random drawing from the two hundred and seven (207) participants who won the qualifying prize. The participant must answer the phone on the first attempt in order to win the grand prize. Station’s decisions as to the administration and operation of the Contest and the selection of the potential winners are final and binding in all matters related to the Contest.

The potential winner will be required to sign and return to Station, within three (3) days of the date notice is sent, an affidavit of eligibility and a liability/publicity release (except where prohibited) to claim the prize, if applicable. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. If a potential winner cannot be contacted, fails to sign and return the affidavit of eligibility and/or the liability/publicity release within the required time period (if applicable), or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize. The approximate retail value (“ARV”) of each prize is ONE HUNDRED DOLLARS (**\$100**).

**Grand Prize.** One (1) Grand Prize will be awarded in this Contest. Each winner will receive:

**Approximate retail value of each Grand Prize Ten Thousand dollars (\$10,000).**

The approximate retail value (“ARV”) of each prize is Ten Thousand Dollars. (**\$10,000**).

**TOTAL ARV OF ALL CONTEST PRIZES IS: THIRTY THOUSAND SEVEN HUNDRED DOLLARS (\$30,700).**

Station reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Contest or to be acting in violation of these Official Rules or acting in an

unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, Station reserves the right to seek damages from any such person to the fullest extent permitted by law. Station's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

- 7. Limitations of Liability.** The Released Parties are not responsible for: (a) any incorrect or inaccurate information, whether caused by Station, entrants, printing errors or by any of the equipment or programming associated with or utilized in the Contest; (b) technical failures of any kind, including but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (c) unauthorized human intervention in any part of the entry process or the Contest; (d) technical or human error that may occur in the administration of the Contest or the processing of entries; or (e) any injury or damage to persons or property that may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Contest or receipt or use, non-use or misuse of any prize. Disputes.** Entrant agrees that: (a) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, shall be resolved individually, without resort to any form of class action; (b) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, shall be resolved exclusively by the United States District Court or the appropriate state court located in the Station's listening area; (c) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Contest, but in no event attorneys' fees; and (d) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. **SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO YOU.** All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrant and Station in connection with the Contest, shall be governed by, and construed in accordance with, the laws of the state in which the Station is located, without giving effect to any choice of law or conflict of law rules (whether of the state in which the Station is located or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the state in which the Station is located.

Station is not responsible for any incorrect or inaccurate information entered by website users, and assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to Station's website.
