KDVV-FM's "Lunch From Robert" Contest

OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station KDVV-FM ("Station"), owned and operated by Cumulus Broadcasting LLC or one of its affiliates, located at 825 S Kansas Ave Suite 100 Topeka, KS 66612, during available business hours Monday through Friday, Station's website at eagle993.com or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **KDVV-FM's "Lunch From Robert"** Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

- 1. No purchase is necessary to enter or win. A purchase will not increase your chance of winning. Void where prohibited. All federal, state, and local regulations apply.
 - **Eligibility.** This Contest is open only to legal U.S. residents, 18 years old or older at the time of entry with a valid Social Security number and who reside in the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, who have not won a prize from the Station in the last 30 Days or a prize valued at \$500 or more in the last 180 days, and whose immediate family members or household members have not won a prize from the Station in the last 30 Days or a prize valued at \$500 or more in the last 180 days. The term "immediate family members" includes spouses, parents and step-parents, siblings and step-siblings, and The term "household members" refers to people who share the same children and stepchildren. residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein. This Contest is in no way sponsored, endorsed, administered by or associated with Facebook.
- 2. Contest Period. The Contest will begin at 2:00pm CT on May 10, 2021 and will run through 4:59pm CT on May 21, 2021 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. How to Enter. Visit the Station's Facebook Page located at facebook.com/v100rocks during the Contest Period and comment on the designated contest post to enter. All entries must be received by 4:59pm CT the following day during the Contest Period to be eligible to win a prize. Limit one (1) entry per person per day, regardless of how many emails/Facebook accounts a person may possess and use. Multiple participants are not permitted to share the same email address. Any attempt by any participant to submit more than one (1) entry by using multiple/different email addresses/Facebook accounts, identities, registrations and logins, or any other methods will void that entry and the participant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. Station is not responsible for lost, late, incomplete, invalid, unintelligible, inappropriate or misdirected registrations, all of which will be disqualified. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the participant. The "authorized account holder" is the natural person assigned the telephone number by the wireless carrier or an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winner may be required to show proof of being the authorized account holder. All entries become the sole and exclusive property of Station and will not be returned. Station reserves the right to

contact entrants and all other individuals whose email address is submitted as part of this promotion. No mail-in entries will be accepted.

4. Winner Selection.

On or around 5:00pm CT each weekday during the Contest Period, the Station will select one (1) entry in a random drawing from among all valid entries received by Station during the Contest Period. There will be ten (10) winners (one for each weekday through the Contest Period).

The winning entrants will be contacted using the Facebook account, email address and/or telephone number provided with the entry and may be awarded the prize and qualify for the Grand Prize drawing (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification and forfeiture of the prize.

- Verification of Potential Winner. THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS 5. IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. If a potential winner cannot be contacted, fails to sign and return the affidavit of eligibility and/or the liability/publicity release within the required time period (if applicable), or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize. 7. **Entry Conditions and Release.** By entering, each participant agrees to: (a) comply with and be bound by these Official Rules and the decisions of the Station, which are binding and final in all matters relating to this Contest; (b) release and hold harmless Station, Cumulus Broadcasting LLC, Cumulus Media New Holdings, Inc., Facebook, and each of their respective subsidiaries, related and affiliated companies, participating sponsors, the prize suppliers and any other organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the Contest, and each of their respective
