## MAJIC 107.7'S "TEXT TO WIN" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station KMAJ-FM ("Station"), 825 S. Kansas Ave, Topeka, KS 66612, during available business hours Monday through Friday, on the Station website www.KMAJ.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **Majic 107.7's "TEXT TO WIN"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. - 2. **Contest Period.** The Contest entry period will begin **5:00 pm Friday, July 8, 2022, and will run through 7:59pm CST Sunday, July 10, 2022** (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. **How to Enter.**

<u>Text</u>: Send a text message with the designated keywords given on-air, spelled correctly to 877-297-1077 during the Contest Period. All entries must be received by 7:59pm on Sunday, July 10, 2022 to be eligible for a chance to win a prize. Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider.

- 4. Winner Selection. On or about 10:00 a.m. on Monday, July 11, 2022, Station will select five (5) potential winners in a random drawing from among all valid entries received by Station to date during the Contest Period. Each winning entrant will be contacted using the telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.
