## MAJIC 107.7'S "TEXT TO WIN" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station KMAJ-FM ("Station"), 825 S. Kansas Ave, Topeka, KS 66612, during available business hours Monday through Friday, on the Station website www.KMAJ.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **Majic 107.7's "TEXT TO WIN"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. - 2. Contest Period. The Contest entry period will begin 12:00am CST July 11, 2022, and will run through 12:00pm CST July 22, 2022. (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. **How to Enter.**

<u>Text</u>: Listen weekday mornings at approximately 6:15 a.m. during contest period for the designated keywords given on-air. Send a text message with the designated keywords given on-air, spelled correctly to 877-297-1077 during the Contest Period. All entries must be received by 6:30 a.m. on each day of the drawing as described below, to be eligible for a chance to win a prize. Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider.

4. Winner Selection. On or about 10:00 a.m. on each day of the contest period, Station will select one (1) potential qualifying winner in a random drawing from among all valid entries received by the station. On or about 10:00 a.m. on July 22, 2022, Station will select one (1) Grand Prize winner in a random drawing from among all valid qualifiers awarded by the station. Each winning entrant will be contacted using the telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within

three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.
