## WODE'S "PARTY ON THE PATIO" REGISTER TO WIN" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WODE (the "Station"), 2158 Avenue C, Suite 100, Bethlehem PA 18017, during available business hours Monday through Friday, Station website <a href="https://www.999thehawk.com">www.999thehawk.com</a>, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct **The Hawk's Party on the Patio at Morgan Hill Golf Course Register to Win"** Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.
  - Eligibility. - 3. **Remote Broadcast.** Attend Party on Patio conducted by Station on **Thursday, June 12**, **2025** from **6:00 PM EST** through **8:30 PM EST** at The View Restaurant at Morgan Hill Golf Course, 100 Clubhouse Dr, Easton, PA 18042 and complete an entry form or receive a raffle ticket. **Limit one (1) entry per person per Thursday Party on the Patio night.** All entries must be received by the deadline stated at the remote broadcast. **LIMIT ONE PRIZE PER PERSON.**
- 4. Winner Selection. Between 6:00 PM EST to 8:30 PM EST on Thursday, June 12, 2025, Station will select up to ten (10) potential winner(s) in a random drawing from among all valid entries received by Station during the Contest Period.
