

## LOOKS SONG OF THE DAY” CONTEST OFFICIAL RULES

obtained by contacting radio station KBUL (öStationö), owned E. Plumb Ln. Reno NV. 89502, during normal business hours addressed, stamped envelope to the above address.

The Station will conduct the KBUL “Garth Brooks Song of the Day” Contest (the öContestö) substantially as described in these rules, and by participating, each participant agrees as follows:

1. **NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.**

**Eligibility.** This Contest is open only to legal U.S. residents, **excluding Florida and New York residents**, age **eighteen (18) years** or older at the time of entry with a valid Social Security number and who reside in the Station’s Designated Market Area (öDMAö) as defined by Nielsen Audio, who have not won a prize from the Station in the last **14 days** or a prize valued at \$500 or more in the **14 days**, and whose immediate family members or household members have not won a prize from the Station in the last **14 days** or a prize valued at \$500 or more in the **14 days** **Void where prohibited by law.** Employees of **Cumulus Radio LLC**, its parent company, affiliates, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, other radio stations serving the Station’s DMA, and the immediate family members and household members of all such employees are not eligible to participate. The term öimmediate family membersö includes spouses, parents and step-parents, siblings and step-siblings, and children and stepchildren. The term öhousehold membersö refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant’s full and unconditional agreement to these Official Rules and Station’s decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein.

2. **Contest Period.** The Contest will begin at **8:10am PT on May 24, 2021** and will run through **6:00 PT on May 28, 1 2021** (the öContest Periodö). The Station’s computer is the official time keeping device for this Contest.

3. **How to Enter.** To enter:

(i) **On-Air:** Listen to the Station weekdays at 8:10am PT during the Contest Period for the Station to announce what the Garth Brooks song of the day is for that day. When the Station plays that same Garth Brooks song again between the hours of 2:00pm and 6:00 pm PT, listeners should call the Station at 775-793-1098. Caller twenty (20) to the Station, as determined by the Station in its sole discretion, will win a Qualifying Prize (as defined below) and be entered to win the Grand Prize (as defined below) (each a öQualifierö). **Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:** Due to the time delay that exists between the Station’s analog over-the-air signal and the Station’s online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station’s analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.

4. **Winner Selection.** On or about 9:45am PT on June 2, 2021, Station will select one (1) entry for the Grand Prize in a random drawing from among all Qualifiers. The winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station’s decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification and forfeiture of the prize.

One (1) Grand Prize will be awarded in this Contest. The Grand Prize is two (2) tickets to see Garth Brooks live in concert at Allegiant Stadium in Las Vegas Nevada on July 10, 2021. **ARV One Hundred Ninety Eight Dollars (\$198.00). Tickets only no travel or lodging included.** Total aggregate ARV of all prizes awarded in this Contest is Four Hundred Eight Dollars (\$408). Winner is responsible for all taxes associated with prize receipt and/or use. Odds of winning a Prize or the Grand Prize depend on a number of factors including the number of eligible entries received during the Contest Period and listeners participating at any given time.
