NEW COUNTRY 96.3 & 99.5 THE WOLF'S "THE KANE BROWN SILVERADO SHOWDOWN" CONTEST OFFICIAL RULES

Limit one (1) entry per person per remote broadcast. All entries must be received by the deadline stated at the remote broadcast. Winner does not have to be present to win. Winners that are not present will be contacted using the phone number or email address provided at the time of entry, by 10:00am CT on the business day immediately following the remote broadcast.
