

NEW COUNTRY 96.3 & 99.5 THE WOLF'S "LAINEY WILSON AT CHOCTAW OCTOBER 11" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station KSCS-FM and KPLX-FM ("Station"), 3090 Nowitzki Way, during available business hours Monday through Friday, on the Station website www.newcountry963.com and www.995thewolf.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the NEW COUNTRY 96.3 & 99.5 THE WOLF'S "LAINEY WILSON AT CHOCTAW OCTOBER 11" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. **NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.**

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number. **Void where prohibited by law.** Employees of Station, WBAP-KSCS Assets, LLC and Radio Metroplex, LLC, and their parent companies, affiliates, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, other radio stations serving the Station's DMA, and the immediate family members and household members of all such employees are not eligible to participate. All entries must be received by 11:59pm CT on September 2, 2024, to be eligible for a chance to win a prize. **Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider. Limit one (1) entry per person per phone number.**

4. **Qualifying Prize Winner Selection.** On or about 10:00am CT on September 3, 2024, Station will select ten (10) potential winners in a random drawing from among all valid entries received by Station during the Contest Period. The winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within one (1) day of notification or failure to claim the prize within one (1) day of verification as a winner will result in disqualification and forfeiture of the prize.

Grand Prize Winner Selection. On or about 11:00am CT on September 3, 2024, Station will select one (1) potential winner in a random drawing from among all valid entries received by Station during the Contest Period. The winning entrant will be contacted using the email address and/or telephone

number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within one (1) day of notification or failure to claim the prize within one (1) day of verification as a winner will result in disqualification and forfeiture of the prize.

A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. The approximate retail value ("ARV") of each prize is Five Hundred Dollars (\$500.00).

Station and any Sponsors make no representation or warranty about the safety of any prize. Station’s failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
