95.5 NASH ICON "SUPERSTAR OF THE DAY" CONTEST OFFICIAL RULES

- 3. Contest Period. The Contest will begin at 5:01 a.m., CT on July 25, 2016 and will run through 9:59 p.m., CT on November 23, 2016 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- **4. How to Enter.** You will automatically be entered into the Contest once you complete the following:
- (i) On-Air: Listen to the Station daily between the hours of 5:00 a.m., CT to 9:59 p.m. CT from July 25, 2016 through November 23, 2016. Each weekday during the dates listed, the station will announce the "Superstar of the Day." When the station plays a song from the "Superstar of the Day" in its entirety, listeners should call the Station at 615-737-9500 after the song ends. Caller number seven (7), once the song ends, to the Station, as determined by the Station in its sole discretion, will win. Time Delay Between Over-the-Air Analog Signal and Internet Broadcast: Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog or digital over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.
- **5. Verification of Potential Winner.** POTENTIAL CONTEST WINNER IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. In the event that the potential winner of a sweepstakes prize is disqualified for any reason, Station may award the applicable prize to an alternate winner. Station reserves the right to substitute any listed prize for one of equal or greater value for any reason.
