

103.3 COUNTRY'S "CARRIE UNDERWOOD FLY AWAY"

CONTEST OFFICIAL RULES

THE STATION WILL CONDUCT THE 103.3 COUNTRY'S "CARRIE UNDERWOOD FLY AWAY" CONTEST (THE "CONTEST") SUBSTANTIALLY AS DESCRIBED IN THESE RULES, AND BY PARTICIPATING, EACH ENTRANT AGREES AS FOLLOWS:
