WARM-FM'S "NORTHERN CENTRAL RAILWAY OF YORK PA COWBOY WEEKEND FACEBOOK GIVEAWAY SEPTEMBER 20-22, 2024" CONTEST OFFICIAL RULES

The Station will conduct the WARM-FM's "Northern Central Railway of York PA Cowboy Weekend Facebook Giveaway September 20-22, 2024" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last thirty (30) days or a prize valued at \$500 or more in the last six (6) months, and whose immediate family members or household members have not won a prize from the Station in the last thirty (30) days or a prize valued at \$500 or more in the last six (6) months. Facebook: Entrants must:

- (b) Comment on the Northern Central Railway of York Pennsylvania Cowboy Weekend post; and
- (c) Include in the comment the word: COWBOY

Any entry comments that are indecent, lewd, offensive, defamatory, contain profanities, or are in any way in bad taste or contain material that may infringe or violate any laws or anyone's rights, as determined in the sole discretion of the Station, may be disqualified. - 4. Winner Selection. On or about 9:00am ET on September 23, 2024, Station will select one (1) potential winner in a random drawing from among all valid entries received by Station during the Contest Period. Each winning entrant will be contacted using the Facebook profile used with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.
- 5. Verification of Potential Winner.
