

**WIOG’S “TEN GRAND IN THE SAND” CONTEST
OFFICIAL RULES**

A complete copy of these rules can be obtained by contacting radio station WIOG (“Station”), 1740 Champagne Drive, Saginaw, MI 48604, during available business hours Monday through Friday, on the Station website www.wiog.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **WIOG’s “Ten Grand in the Sand”** Contest (the “Contest”) substantially as described in these rules, and by participating, each entrant agrees as follows:

1. **NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.**

Eligibility. This Contest is open only to legal U.S. residents of the Station’s Designated Market Area (“DMA”) as defined by Nielsen Audio, excluding Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last thirty (30) days or a prize valued at \$500 or more in the last six (6) months, and whose immediate family members or household members have not won a prize from the Station in the last thirty (30) days or a prize valued at \$500 or more in the last six (6) months. **Void where prohibited by law.** Employees of Station, Cumulus Radio LLC, and each of their parent companies, affiliates, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, other radio stations serving the Station’s DMA, and the immediate family members and household members of all such employees are not eligible to participate. The term “immediate family members” includes spouses, parents and step-parents, siblings and step-siblings, and children and stepchildren. The term “household members” refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant’s full and unconditional agreement to these Official Rules and Station’s decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein.

2. **Contest Period.** The Contest entry period will begin at **7:00 am ET on June 31, 2022** and will **run** through **5:59 pm ET on June 24, 2022** (the “Contest Period”). The Station’s computer is the official time keeping device for this Contest.

3. **How to Enter. There are four (4) ways to enter this Contest.**

(i) On-Air: Listen to the Station weekdays from 7:00 am to 7:59 am, 8:00 am to 8:59 am, 11:00 am to 11:59 am, 3:00pm to 3:59pm, and 5:00pm to 5:59pm (all times eastern) during the Contest Period. . When the Station plays the “cue-to-call” sounder, listeners must call the Station at 877-330-9464. Caller twenty-five (25) to the Station, as determined by the Station in its sole discretion, will be entered for a chance to win a prize at the Finale Event (described below) (each a “Qualifier”). **Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:** Due to the time delay that exists between the Station’s analog over-the-air signal and the Station’s online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station’s analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished. Station will qualify up to 95 qualifiers on-air in this contest

(ii) Remote Broadcast: Attend the remote broadcast conducted by Station on June 10, 2022 from 12:00 pm ET through 2:00 pm ET at Financial Plus Credit Union, 4686 Fashion Square Blvd, Saginaw, MI 48604 and complete an entry form. **Limit one (1) entry per person per remote broadcast.** All entries must be received by the deadline stated at the remote broadcast. At the conclusion of the remote broadcasting, Station will select two (2) entries to be Qualifiers from all eligible entries received by Station at the remote broadcast.

(iii) Online: From 7:00 am ET on June 5, 2022 through 11:59 pm ET on June 12, 2022 (“Online Entry Period”), visit the Station’s website www.wiog.com, click on the “Contest” link, click on the “Five Grand in the Sand” Contest link, and complete an entry form. All entries must be received by 11:59 pm ET on June 12, 2022 to be eligible for a chance to win a prize. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to submit more than one (1) entry per day by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entry and the entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. Station is not responsible for lost, late, incomplete, invalid, unintelligible, inappropriate or misdirected registrations, all of which will be disqualified. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the entrant. The “authorized account holder” is the natural person assigned the telephone number by the wireless carrier or an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winner may be required to show proof of being the authorized account holder. All entries become the sole and exclusive property of Station and will not be returned. Station reserves the right to contact entrants and all other individuals whose email address is submitted as part of this promotion. No mail-in entries will be accepted.

(iv) Text: From 7:00 am ET on June 5, 2022 through 11:59 pm ET on June 12, 2022 (“Text Entry Period”), send a text message with the keyword plus spelled correctly to 64636. All entries must be received by 11:59pm ET on June 12, 2022 to be eligible for a chance to win the grand prize. **Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider.**

Texting in will not increase your chances of winning. Limit one (1) online or text entry per person per day. Entrants may submit one (1) online or text entry per day but not both.

On or about 11:00 am ET on June 13, 2022, Station will select five (5) entries to be Qualifiers in a random drawing from among all valid text and online entries received by Station during the Online Entry Period and Text Entry Period.

4. **Winner Selection at Finale.** Station will conduct the Finale Event in this Contest on Saturday, June 25, 2022 at Haithco Park, 2121 Schust Road, Saginaw, MI 48603. **Qualifiers must attend the Finale Event to participate and have the opportunity win.** Qualifiers must check in with Station at the Finale Event from 8:45 am to 9:30 am ET with a valid government issued ID. Any Qualifiers not checked in by 9:30 am ET will be disqualified. On or about 9:45 am ET, Station will conduct a reverse random drawing from all eligible checked in Qualifiers in the Contest. There will be up to one hundred two (102) total Qualifiers in this Contest from all entry methods (on-air, remote broadcast, text, and online entries). There will be a total of one hundred two (102) plastic capsules, and each capsule will contain one (1) number between 1 – 102. Each number will be assigned to a prize in the Contest. Qualifiers names will be drawn one (1) at a time at random to enter the sand (volleyball court) and dig for one (1) capsule. In the event a Qualifier is unable to participate due to physical limitations, the Qualifier is allowed to choose a proxy/substitute to dig for their capsule. Each Qualifier will locate a capsule and will win the prize associated with the number in the capsule (subject to verification of eligibility and compliance with the terms of these rules). Prizes will be announced once all participating Qualifiers find a capsule. Station’s decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to claim the prize within three (3) days of Finale Event and verification as a winner will result in disqualification and forfeiture of the prize.

5. **Verification of Potential Winner.** THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination. The potential winner will be required to sign and return to Station, within three (3) days of the date notice is sent, an affidavit of eligibility and a liability/publicity release (except where prohibited) to claim the prize, if applicable. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. If a potential winner cannot be contacted, fails to sign and return the affidavit of eligibility and/or the liability/publicity release within the required time period (if applicable), or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize. Any attempt by any person to deliberately undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, Station reserves the right to seek damages from any such person to the fullest extent permitted by law. Station's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
11. **Limitations of Liability.** The Released Parties are not responsible for: (a) any incorrect or inaccurate information, whether caused by Station, Sponsor(s), entrants, printing errors or by any of the equipment or programming associated with or utilized in the Contest; (b) technical failures of any kind, including but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (c) unauthorized human intervention in any part of the entry process or the Contest; (d) technical or human error that may occur in the administration of the Contest or the processing of entries; or (e) any injury or damage to persons or property that may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Contest or receipt or use, non-use or misuse of any prize. In event that a production, technical, programming or other error causes more than stated number of prizes as set forth in these Official Rules to be claimed, Station reserves the right to award only the stated number of prizes by a random drawing among all legitimate, unawarded, eligible prize claims.
12. **Disputes.** Entrant agrees that: (a) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, shall be resolved individually, without resort to any form of class action; (b) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, shall be resolved exclusively by the United States District Court or the appropriate state court located in the Station's listening area; (c) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Contest, but in no event attorneys' fees; and (d) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. **SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO YOU.** All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrant and Station in connection with the Contest, shall be governed by, and construed in accordance with, the laws of the state in which the Station is located, without giving effect to any choice of law or conflict of law rules (whether of the state in which the Station is located or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the state in which the Station is located.

Station is not responsible for any incorrect or inaccurate information entered by website users, and assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to Station's website.
