## Z93's "Summer Survival Kit" Contest Official Rules

A complete copy of these rules can be obtained by contacting radio station WKQZ ("Station"), owned and operated by Cumulus Radio LLC, 1740 Champagne Dr, Saginaw, MI 48604, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **Z93's "Summer Survival Kit"** Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

- 1. No purchase is necessary to enter or win. A purchase will not increase your chance of winning. Void where prohibited. All federal, state, and local regulations apply.
  - **Eligibility.** This Contest is open only to legal U.S. residents, excluding Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number and who reside in the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, who have not won a prize from the Station in the last 30 days or a prize valued at \$500 or more in the six (6) months, and whose immediate family members or household members have not won a prize from the Station in the last 30 days or a prize valued at \$500 or more in the six (6) months. Void where prohibited by law. Employees of Cumulus Radio LLC, its parent company, affiliates, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, other radio stations serving the Station's DMA, and the immediate family members and household members of all such employees are not eligible to participate. The term "immediate family members" includes spouses, parents and step-parents, siblings and step-siblings, and children and stepchildren. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein.
  - 2. Contest Period. The Contest will begin at 7:00am ET on June 7, 2021 and will run through 4:59pm ET on June 25, 2021. The Station's computer is the official time keeping device for this Contest.
  - **3.** How to Enter & Win. To enter:
    - (i) On-Air & <u>Text</u>: During each weekday of the Contest Period, the Station will announce a unique keyword over the air at 7:00am, 11:00am, and 4:00pm ET (each a "Contest Round"). When Station announces the keyword for that hour, send a text with the keyword spelled correctly to 68255. All entries must be received by the end of the Contest Round in which the keyword is announced (i.e. 7:59am, 11:59am, and 4:59am ET) to be eligible to win. Standard text message rates, as established by an individual's wireless carrier, may apply, and Station assumes no responsibility for any fees or charges incurred for and associated with any text message sent to or from Station. Any and all fees arising out of the transmission of text message shall be the sole responsibility of the entrant. Limit one (1) entry per person per phone number per Contest Round. Multiple

- participants are not permitted to share the same telephone number. Any attempt by any participant to submit more than one (1) entry per Contest Round by using multiple/different telephone numbers, identities, or any other methods will void that participant from further participation in the Contest. *Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:* Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.
- **4.** Winner Selection: At the conclusion of each Contest Round, Station will select one (2) entry to qualify for the finale event beginning at 10:00am ET on June 26, 2021 at Dolney RV Center (1171 S. Huron Rd, Kawkawlin, MI 48631) ("Finale Event") in a random drawing from among all valid entries received by Station during the Contest Round immediately preceding the drawing (each a "Qualifier"). There will be up three Qualifiers per day for a total of forty-five Qualifiers in the Contest. All Qualifiers must attend the Finale Event to be eligible to win. Qualifiers must check in between 10:00am to 10:59am ET. No late check ins will be allowed. Any Qualifier not checked in by 10:59am ET will disqualified. On or about 11:00am ET, Station will conduct a random reverse drawing from among the valid and checked-in Qualifiers. The Prize Provider will select one (1) Qualifier's name in a random drawing. The Qualifier whose name is selected will be eliminated from the Contest and will select the next Qualifier's name. This process continues until only one (1) Qualifier remains. The last three (3) Qualifiers remaining will each win a prize (as defined below). The last Qualifier remaining will select one (1) of three (3) prize options. The second to last Qualifier will select one (1) of the remaining two (2) prize options. The third to last Qualifier will win the remaining prize option. **MUST BE PRESENT TO WIN.** The winning entrants will be notified at the event and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to claim the prize within thirty (30) days of winning will result in disqualification and forfeiture of the prize.

Sponsor makes no representation or warranty about the safety of the Finale Event in light of COVID-19. By attending the Finale Event, participants acknowledge the risk of large group gatherings and assume all risks of attending the Finale Event.

5. Verification of Potential Winner. THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The potential winner must continue to comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. The potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination. The potential winner will be required to sign and return to Station, within three (3) days of the date notice is sent, an affidavit of eligibility and a liability/publicity release (except where prohibited) in order to claim his/her prize, if applicable. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to

rescind their acceptance of the prize and/or return the prize. If a potential winner cannot be contacted, fails to sign and return the affidavit of eligibility and/or the liability/publicity release within the required time period (if applicable), or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize. In the event that the potential winner of a prize is disqualified for any reason, Station may award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries.

- **6. Prizes.** Up to three (3) prizes will be awarded in this Contest. The prize options are as follows:
  - Prize #1: one (1) Traeger Pro 34 Grill, one (1) shelf, one (1) grill cover, one (1) bag of pellets, one (1) bottle of BBQ sauce, one (1) bottle of BBQ rub, and one (1) Dolney RV t-shirt. **ARV** Nine Hundred Dollars (\$900).
  - Prize #2: one (1) Traxxas E-Revo 2.0 Remote Control Car, one (1) charger, two (2) batteries, and one (1) Dolney RV t-shirt **ARV** Eight Hundred Fifty Five Dollars (\$855).
  - Prize #3: one (1) Yeti V Series Cooler and one (1) Dolney RV t-shirt **ARV** Eight Hundred Twenty Five Dollars (\$825).

Total aggregate **ARV** of all Prizes awarded in this Contest is Two Thousand Five Hundred Eighty Dollars (\$2,580). Winner is responsible for all taxes associated with prize receipt and/or use. If winners are unable to use the Prize due to closures related to disease, epidemic, pandemic, quarantine, any acts of government, and/or any reason that is beyond the control of Sponsors, then no substitution shall be provided by Sponsors. Sponsors make no representation or warranty about the safety of redeeming the Prize in light of COVID-19. past and present officers, directors, employees, agents and representatives (collectively, the "Released Parties") from and against any and all claims, expenses, and liability, including but not limited to negligence and damages of any kind to persons and property, including but not limited to invasion of privacy (under appropriation, intrusion, public disclosure of private facts, false light in the public eye or other legal theory), defamation, slander, libel, violation of right of publicity, infringement of trademark, copyright or other intellectual property rights, property damage, or death or personal injury arising out of or relating to a participant's entry, creation of an entry or submission of an entry, participation in the Contest, acceptance or use or misuse of prize (including any travel or activity related thereto) and/or the broadcast, exploitation or use of entry; and (c) indemnify, defend and hold harmless the Released Parties from and against any and all claims, expenses, and liabilities (including reasonable attorneys' fees) arising out of or relating to an entrant's participation in the Contest and/or entrant's acceptance, use, non-use or misuse of the prize.

Station reserves the right to cancel, suspend and/or modify the Contest, or any part of it, if any fraud, technical failures or any other factor beyond Station's reasonable control impairs the integrity or proper functioning of the Contest, as determined by Station in its sole discretion. Station reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Contest or to be acting in violation of these Official Rules or acting in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, Station reserves the right to seek damages from any such person to the fullest extent permitted by law. Station's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
- 11. Limitations of Liability. The Released Parties are not responsible for: (1) any incorrect or inaccurate information, whether caused by Station, entrants, printing errors or by any of the equipment or programming associated with or utilized in the Contest; (2) technical failures of any kind, including but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (3) unauthorized human intervention in any part of the entry process or the Contest; (4) technical or human error which may occur in the administration of the Contest or the processing of entries; or (5) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Contest or receipt or use, non-use or misuse of any prize. No more than the stated number of prizes will be awarded. In event that a production, technical, programming or other error causes more than stated number of prizes as set forth

in these Official Rules to be claimed, Station reserves the right to award only the stated number of prizes by a random drawing among all legitimate, unawarded, eligible prize claims.

- 12. Disputes. Entrant agrees that: (i) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, shall be resolved individually, without resort to any form of class action; (ii) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, shall be resolved exclusively by the United States District Court or the appropriate state court located in the Station's listening area; (iii) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Contest, but in no event attorneys' fees; and (iv) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO YOU. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrant and Station in connection with the Contest, shall be governed by, and construed in accordance with, the laws of the state in which the Station is located, without giving effect to any choice of law or conflict of law rules (whether of the state in which the Station is located or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the state in which the Station is located.
- 13. Entrant's Personal Information. Information collected from entrants is subject to Station's Privacy Policy, which is available on the Station's website under the "Privacy Policy" link. All entry blanks, forms, devices, and materials gathered during the course of entry, as well as all information contained therein, shall become the sole property of Station to be used, disposed of or destroyed in its sole discretion. Station is not responsible for any incorrect or inaccurate information entered by website users, and assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to Station's website.
