WNNK's "THE WINK WAKE UP SHOW DUNKIN' TEACHERS APPRECIATION WEEK CONTEST" OFFICIAL RULES

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. Station reserves the right to contact entrants and all other individuals whose email address is submitted as part of this promotion. No mail-in entries will be accepted.

4. Winner Selection.

Starting on Monday, May 3, 2021 until Friday, May 7, 2021, Station will select one (1) entry each weekday for the prizes in a random drawing from among all valid entries received by Station during the Contest Period. A daily winner will be announced each weekday morning at about 6:50 am ET starting Monday, May 3, 2021 until Friday, May 7, 2021. Each winner will receive one prize. Exact prize and value are further described in Section 6 of these Contest Rules. The winning entrants will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification and forfeiture of the prize.
