## WQXA'S "KORN & STAIND WEEKEND GIVEAWAY" CONTEST OFFICIAL RULES

The Station will conduct the **WQXA's** "**Korn & Staind Weekend Giveaway**" Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents, excluding Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number and who reside in the Station's Designated Market Area ("DMA") as defined by Nielsen Audio. Void where prohibited by law. ## 3. **How to Enter.**

All entries must be received by 11:59pm ET on May 16, 2021 to be eligible for the prize drawing. Limit one (1) entryper person per day, regardless of how many email addresses a person may possess and use. Multiple participants are not permitted to share the same email address. Any attempt by any participant to submit more than one (1) entry per day by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entry and the participant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. Station is not responsible for lost, late, incomplete, invalid, unintelligible, inappropriate or misdirected registrations, all of which will be disqualified. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the participant. The "authorized account holder" is the natural person assigned the telephone number by the wireless carrier or an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winner may be required to show proof of being the authorized account holder. All entries become the sole and exclusive property of Station and will not be returned. Station reserves the right to contact entrants and all other individuals whose email address is submitted as part of this promotion. Nomail-in entries will be accepted.

## 4. Winner Selection.

On Monday, May 17, 2021, Station will select ten (10) entries for the prizes in a random drawing from among all valid entries received by Station during the Contest Period. Each winner will receive one

prize. Exact prize and value are further described in Section 6 of these Contest Rules. The winning entrants will be contacted using the email address and/or telephone number provided with the entry and may be awardedthe prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification and forfeiture of the prize.

- 5. Verification of Potential Winner.
