WQXA'S "LEBANON FAIR REGISTER TO WIN LAKE TOBIAS WILDLIFE PARK TICKETS" CONTEST OFFICIAL RULES

The Station will conduct the WQXA's "Lebanon Fair Register To Win Lake Tobias Wildlife Park Tickets" Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. Attend the remote broadcast conducted by Station at the Lebanon Fair, 80 Rocherty Road, Lebanon, PA 17042 on Wednesday, July 28, 2021 between 5:00pm ET and 7:00pm ET and complete an entry form. Limit one (1) entry per person per remote broadcast. All entries must be received by the deadline stated at the remote broadcast.

Station's decisions as to the administration and operation of the Contest and the selection of the potential winners are final and binding in all matters related to the Contest. Failure to verify winner's eligibility may result in disqualification and forfeiture of the prize. Unclaimed prizes may not be awarded.

4. Winner Selection.

On or about 7:00pm ET on July 28, 2021 Station will select one (1) potential winner in a random drawing from among all valid entries received by Station during the Contest Period. Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification and forfeiture of the prize.

- 5. Verification of Potential Winner.
