WQXA'S "BREAKING BENJAMIN TICKET GIVEAWAY AUGUST 4-10, 2021" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station WQXA ("Station"), 2300 Vartan Way, Suite 130, Harrisburg, PA 17110, during available business hours Monday through Friday, on the Station website www.1057thex.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the WQXA's "Breaking Benjamin Ticket Giveaway August 4-10, 2021" Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number. **Void where prohibited by law.** Employees of Station, Cumulus Radio LLC, and each of their parent companies, affiliates, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, other radio stations serving the Station's DMA, and the immediate family members and household members of all such employees are not eligible to participate. The term "immediate family members" includes spouses, parents and step-parents, siblings and step-siblings, and children and stepchildren. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. 2. Contest Period. The Contest will begin at 6:00am ET on August 4, 2021, and will run weekdays from 6:00am ET until 10:00am ET through 10:00am ET on August 10, 2021, (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.

3. How to Enter On-Air:

Listen to the Station during the Contest Period. When the Station announces and/or plays the "cue-tocall" sounder, listeners must call the Station at 1-800-332-1057 or 717-998-0273. Caller #10 to the Station, as determined by the Station in its sole discretion, will be the winner for that Selection Day after providing the Station the winning listener's name and phone number, subject to verification and compliance with these Contest Rules. All entries may be played on the air. <u>*Time Delay Between Over-*</u> <u>*the-Air Analog Signal and Internet Broadcast:*</u> Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.

Station's decisions as to the administration and operation of the Contest and the selection of the potential winners are final and binding in all matters related to the Contest. Failure to verify winner's eligibility may result in disqualification and forfeiture of the prize. Unclaimed prizes may not be awarded. **LIMIT ONE PRIZE PER PERSON.**

4. Winner Selection.

Each day of the Contest, a prize winner will be selected based upon the entry method described in Section 3. The prize winner will be Caller #10 at each time the Contest is played. In the event there is not a caller on the contest phone lines when Caller #10 is selected, the Station will advance to the next Caller, and further, if need be, until a prize winner is selected each time the Contest is played. The winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest. Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification and forfeiture of the prize.
